Introduction

Welcome to the Investigator and Site Personnel Good Clinical Practice (ICH GCP) online training program.

The ICH Good Clinical Practice (GCP) Guideline (ICH E6 R2) is a unified, globally recognised, ethical, scientific, and quality standard for conducting clinical trials. It sets the responsibilities and expectations of sponsors, investigators, and all other professionals involved in designing, conducting, monitoring, recording, and reporting of clinical trials. Complying with the guideline helps to ensure that the rights, safety, and well-being of participants are protected, and that the trial data and results are reliable.

The course satisfies the Minimum Criteria for Good Clinical Practice (GCP) training of investigators and site personnel (based upon ICH E6 R2) as defined by [TransCelerate](#). To satisfy these criteria, the course includes an overview of GCP, the principles of ICH GCP, and investigator responsibilities. Additionally, our course provides an overview of the Australian regulatory environment, and the roles and responsibilities of the sponsor, contract research organisation, and clinical trial monitor.

Course Overview

The Investigator and Site Personnel Good Clinical Practice (ICH GCP) online training program is an online, self-paced learning course consisting of two (2) lessons. Each lesson is organised into a series of topics, with 16 topics in total.

Each topic consists of one page of learning materials. Written content is accompanied by short videos, summary tables, and diagrams (including our own purpose-made infographics). References and recommended readings are listed at the end of each topic.

A GCP course assessment quiz will become accessible upon completion of the two lessons. A passing grade of at least 80% is required to pass the course and receive a certificate of completion.

The course and certificate are compliant with the [TransCelerate Site Qualification and Training \(SQT\) Initiative](#), reflecting professional recognition for ICH E6 Good Clinical Practice (GCP) Training targeted to investigator site personnel. The certificate is valid for a period of 3 years.

The course takes approximately 2 - 4 hours to complete.

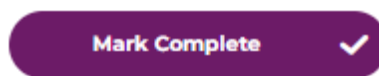
Course Content

You will need to correctly answer at least **16 of the 20** questions (**a score of at least 80%**) to pass each unit.

There is no time limit. You may attempt the quiz as many times as you need to.

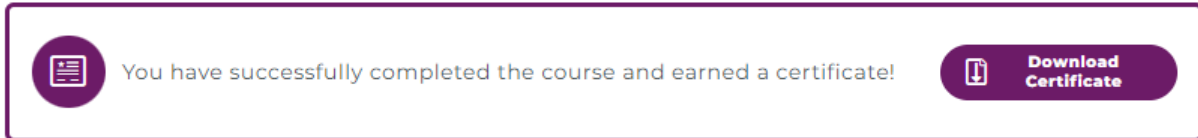
